Council Member Lanessa Arthur-Westervelt

Council Member Lucas Stansbury

Thanks, the city employees, for all the hard work and a lot of long hours. Some of the jobs in the summer are not the most fun but knows we have individuals that go out there and do it every day, day in day out. Saw fire trucks out and seen someone sweeping the inside of the building so that's always nice to see employees caring about how the facilities looks, disc golf looks good, and he seen there are some hazards probably from last windstorm, golf course has heard good things about it and the restaurant. The police force heard good things about them, and patrols have even been seen in the neighborhood sometimes and appreciates that and all the officers on what they do. The skate park has heard good things about the pickleball net, and he has used it himself with a group of guys he plays with. His only concern was about how slick it was. Inquired about the restrooms, possibly finding out a solution to have them available.
